- 5. Events The Annul Pancake Breakfast will be held on Saturday, August 19th from 7:30 AM to 11:00 AM. Price of breakfast is \$7.00 for adults and \$4.00 for children. Someone suggested we might want to do a 50/50 raffle during the breakfast. Kathy Hoelzel will contact Jonathan Wood to make sure his group is all set.
- Building Issues Dennis Garnham stated we should vent the buildings for cross flow and protection of the roof plus it will decrease interior maintenance as well. Venting will increase the longevity of the buildings and lower maintenance costs.

Motion: By Kathy McDonald, duly seconded by Marge Desjardins to authorize Dennis Garnham to purchase and install vents, as a donation, for the three small buildings.

Voted in the Affirmative by all in attendance.

The painting of the Caboose floors needs to be finished. This will be put on the August agenda.

- 7. Granite Posts The chains have been continually pulled out. Dennis stated he could use tie wraps around the chains and this should work for a cheap fix.
- 8. Keys Please let Kathy Hoelzel know if you have a key and give her the number of the key. The key should be given back when you leave the society. A list will be made with the names of everyone who has a key along with the number of the key. A suggestion was made that we should have a sign in and sign out sheet.

- 9. Copy Machine It was mentioned that we might want to have a copy machine at the Depot. Marge stated she has a copy machine we could use and she will bring it in to try out.
